FREEDOM OF INFORMATION – Victorian Energy Efficiency Certificates – Victorian Energy Upgrades (**VEU**) program – Non-Building Based Lighting Upgrades – constructive possession – personal affairs information – privacy of third parties

All references to legislation in this document are to the *Freedom of Information Act 1982* (Vic) (**FOI Act**) unless otherwise stated.

Notice of Decision

I have conducted a review under section 49F of the Agency's decision to refuse access to documents requested by the Applicant under the FOI Act.

My decision on the Applicant's request differs from the Agency's decision and more information is to be released where I am satisfied it is not exempt under section 33(1).

The Schedule of Documents in **Annexure 1** sets out my decision in relation to each document.

Please refer to page 9 for information about review rights through the Victorian Civil and Administrative Tribunal (VCAT).

Reasons for Decision

Background to review

- 1. The Applicant made a request to the Agency seeking access to documents with respect to Activity 35 Non-Building Based Lighting Upgrades and sought access to 'all documents, photographs, and evidence' relating to [several sites relating to a company]. The Applicant also specified they wanted access to:
 - (a) Pre-Design Consultation Documents:
 - Records of engagement with consumers to establish lighting needs for each site.
 - (b) Baseline Lighting Condition Surveys
 - Documentation of equipment and design performance of baseline lighting conditions
 - (c) Lighting Design Plans;
 - All plans, maps, and documentation related to the lighting replacement projects at the specified sites.
 - Including initial designs, revisions, and final versions.
 - (d) Simulated Lighting Designs;
 - Computer-generated lighting simulations in accordance with AS/NZS 1158 standards.
 - (e) Specifications and Instructions;
 - Specifications for suitable lighting consistent with the photometrics of the baseline lighting.
 - Instructions on mounting methods, pole fixings, corrosion protection, cable protection, and measures to ensure fasteners do not come loose.
 - (f) Compliance Declarations;
 - Completed forms DMS 602 ASNZS 1158 Compliance Declaration Activity 35, and any attachments.
 - (g) Photographs and Images;
 - Taken before, during, and after the completion of the lighting replacement, including decommissioned equipment.
 - (h) Reports, Assessments, or Evaluations
 - Internal and external reports, assessments, or evaluations regarding the lighting replacement at the specified sites.

- (i) Internal and External Communications
 - Written communications both internally and externally between the AP and the ESC, relating to the lighting replacement projects at the specified sites.
- (j) Qualified Third-Party Reports and Advice.
 - Reports, advice, investigations, or written communications from qualified third parties pertaining to the upgrade outcomes at the specified sites.
- 2. The Applicant stated in their request that they were requesting documents on behalf of [a company] and that their purpose was to gather evidence related to the compliance and quality of lighting upgrades conducted under Activity 35 at the [specified sites concerning the company]. They stated the information would aid in assessing whether the necessary planning and compliance verification work was appropriately undertaken.
- 3. The Agency identified 106 documents falling within the Applicant's request and refused access to information in certain information in the documents under section 33(1). A summary of the Agency's decision is set out in the Schedule of Documents in **Annexure 1**. The Agency's decision letter sets out the reasons for its decision.

Review application

- 4. The Applicant sought review by the Information Commissioner under section 49A(1) of the Agency's decision to refuse access.
- 5. I have examined a copy of the documents subject to review.
- 6. The Applicant and the Agency were invited to make a written submission under section 49H(2) in relation to the review.
- 7. I have considered relevant communications and submissions received from the parties.
- 8. In their review application, the Applicant raised concerns about the adequacy of the Agency's document searches in relation to their FOI request. The Agency's decision letter states:

The searches did not identify evidence held by the commission at the time of your request in respect of other sites mentioned in Request 2. I am satisfied that the commission does not hold such documents, given that:

- (a) Certificates have not been created in respect of all sites, so the commission would not have evidence in relation to those installations; and
- (b) The commission does not hold documentary evidence in respect of all prescribed activities/certificates created only a sample.
- 9. The Applicant submitted that the Agency has constructive possession of all documents related to upgrades conducted under the Victorian Energy Upgrades (VEU) program, and as the regulatory body overseeing the VEU program, and the Agency has statutory authority under the Victorian Energy Efficiency Target Act 2007 (Vic) (VEET Act) to compel Accredited Persons to produce documents for regulatory purposes.

- 10. In my view, the Agency does not have constructive possession of documents held by Accredited Persons where it can only obtain the documents through the exercise of its statutory powers to compel the production of documents and information and has not already exercised these powers. The Agency's statutory powers do not equate to a statutory right of immediate possession or control to all documents that might be subject to a notice under section 60 of the VEET Act or inspected by an authorised officer. A lawful exercise of these statutory powers by the Agency may create an immediate right to possession (constructive possession), but without the prior exercise of those powers it cannot be said that such a right existed at the time of the FOI request.
- 11. The Applicant also sought to expand the review to include all registered and unregistered lighting upgrade activities at all [other sites owned by the company] and requested a CSV export detailing every instance of a prescribed activity at these sites. The Applicant's FOI request cannot be expanded as part of their review application, and as such, I have only reviewed the documents that were subject to the Agency's decision.
- 12. In undertaking my review, I have had regard to the object of the FOI Act, which is to create a general right of access to information in the possession of the Government or other public bodies, limited only by exceptions and exemptions necessary to protect essential public interests, privacy and business affairs.
- 13. I note Parliament's intention the FOI Act must be interpreted so as to further the object of the Act and any discretions conferred by the Act must be exercised, as far as possible, so as to facilitate and promote the disclosure of information in a timely manner and at the lowest reasonable cost.

Review of exemption

Section 33(1) – Documents affecting personal privacy of third parties

- 90. A document or information is exempt under section 33(1) if two conditions are satisfied:
 - (a) the document or information relates to the 'personal affairs' of a natural person (living or deceased); and
 - (b) disclosure of that personal affairs information is unreasonable in all the circumstances.

Do the documents contain personal affairs information of individuals other than the Applicant?

- 91. The Agency has exempted names, signatures, contact details of people involved in relation to non-building lighting upgrade activities for several sites. It includes details concerning the energy consumers, the accredited provider, including the lighting designer, the upgrade manager and persons who undertook work.
- 92. The Agency also exempted licence numbers, Certificate of Electrical Safety numbers and membership numbers concerning certain third parties.
- 93. The Agency exempted names of Agency officers in one document.

Would disclosure of the personal affairs information be unreasonable?

- 94. The concept of 'unreasonable disclosure' involves balancing the public interest in the disclosure of official information with the personal interest in privacy in the particular circumstances of a matter.
- 95. In *Victoria Police v Marke*, ¹ the Victorian Court of Appeal held there is 'no absolute bar to providing access to documents which relate to the personal affairs of others'. Further, the exemption under section 33(1) 'arises only in cases of unreasonable disclosure' and '[w]hat amounts to an unreasonable disclosure of someone's personal affairs will necessarily vary from case to case'. ² The Court further held, '[t]he protection of privacy, which lies at the heart of [section] 33(1), is an important right that the FOI Act properly protects. However, an individual's privacy can be invaded by a lesser or greater degree'. ³
- 96. In determining whether disclosure of the personal affairs information would be unreasonable in the circumstances, I have considered the following factors:⁴
 - (a) The circumstances in which the information was obtained

The Applicant sought access to documents held by the Agency with respect to non-building based lighting upgrades activity for specified sites as part of the VEU program. The VEU program allows Victorians to upgrade their homes and businesses with energy efficient products and services by offering discounts and rebates. When homes or businesses are made more energy-efficient through the VEU program, Victorian Energy Efficiency Certificates (VEEC) are created. VEECs can only be created by entities accredited by the Agency under the VEU program, known as accredited persons. Once a VEEC is created, they are purchased by energy retailers from the accredited persons, and the energy retailers use them to meet their annual emission targets set by the Victorian Government.

The Applicant's request concerns 'activity 35', which is also known as a non-building based lighting upgrade in the VEU program.

The Agency's website sets out information about how it regulates the VEU program. It states that it is responsible for administering the VEU program and regulating program participants and its responsibilities include to:

• accredit persons who are able to create VEECs under the program;

- validate the creation of certificates for registration;
- administer the registration, transfer and surrender of VEECs;
- approve energy efficient products that can be installed under the VEU program;
- set performance standards for certain products to be installed under the VEU program;
- monitor compliance with the VEET Act, regulations and guidelines, including the code of conduct;
- issue shortfall statements and enforce energy efficiency shortfall penalties; and
- maintain electronic registers.⁹

Once a VEEC is created by an accredited person, the Agency will assess it and decide whether to register the VEEC. 10

The documents were obtained by the Agency as part of its processes involved in administering and regulating the VEU program. They include documents that were submitted to the Agency for the purpose of creating VEECs for specified activities.

(b) The nature of the personal affairs information

The nature of the personal affairs information in the documents is not sensitive. It identifies third parties who were involved in the lighting upgrades for various sites, including the energy consumer, the accredited provider, including the lighting designer, the upgrade manager and persons who undertook work.

One document includes details of Agency officers, which I also consider is not sensitive personal affairs information as it concerns those officers undertaking their ordinary responsibilities.

(c) The extent to which the information is available to the public

The documents are not publicly available. However, the Agency has exempted telephone numbers for businesses that are publicly available on the businesses' websites.

(d) The Applicant's interest in the information

The Applicant's stated purpose is to gather evidence related to the compliance and quality of lighting upgrades at the sites to assess whether necessary planning and compliance verification work was appropriately undertaken.

I have also considered the Applicant's written submissions which sets out further reasons for seeking access to the documents. In summary, the Applicant submits:

- (a) they consider there have been unauthorised upgrades carried out without proper consent and documentation;
- (b) the redaction of personal affairs information hinders [the company's] ability to conduct a thorough investigation;
- (c) [the company] has a legitimate need to verify the authenticity of documents and raises concern of fraudulent certifications;
- (d) the redactions limit [the company's] capacity to ensure compliance with safety regulations and to investigate potential contractual breaches;
- (e) the withholding of information contradicts the rights of consumers under the VEU program which provides that consumers are entitled to comprehensive information regarding the program, including details about the products, services, and parties involved;
- (f) withholding information prevents [the company] from exercising their rights under the Australian Consumer Law;
- (g) the Agency's statement about holding evidence only for sites with created VEECs suggests a possibility that documentation for sites where activities occurred but did not result in valid VEECs due to compliance breaches, and therefore, if the Agency invalidated or withdrew VEEC claims, the associated documentation is even more important for understanding the nature and extent of potential consumer harm;
- (h) it prevents [the company] from verifying the safety and compliance of the lighting upgrades which could expose them to liabilities;
- (i) as an affected party, [the company] must have access to all relevant documents to investigate potential breaches and protect its legal rights;
- (j) the Agency has prioritised the reputation of Accredited Persons over the safety of consumers;
- (k) there have been systemic failures in the Agency's oversight and it may be concealing information that reveals it failed to regulate Activity 35;
- (I) consumers affected by fraudulent upgrades have the right to access all relevant documentation regarding works performed on their properties.

The Applicant also considers that provisions of the VEET Act gives the consumer explicit and unconditional access to the documents.

The Agency has released all information to the Applicant except for the personal affairs information of third parties involved in the activities.

(e) Whether any public or important interest would be promoted by release of the information

I consider that there is a public interest in the proper administration of the VEU program, including that VEECs are not deceptively created. Nevertheless, I consider disclosure of the personal affairs information would promote the Applicant's private interest, rather than a public interest, and note that any potential issues concerning the creation and assignment of VEECs with respect to the sites specified in the Applicant's request can be dealt with via processes outside of FOI.

(f) Whether the individuals to whom the information relates object, or would be likely to object, to the release of the information

The Agency did not consult with all third parties identifiable in the documents, however, it did consult with the Accredited Person.

In the circumstances of this matter, I consider it would be reasonably likely that the third parties would object to the disclosure of their personal affairs information to the Applicant.

(g) Whether disclosure of the information would or would be reasonably likely to endanger the life or physical safety of any person $\frac{11}{2}$

I do not consider this is relevant in the circumstances of this matter.

- 97. I am satisfied that it would not be unreasonable to disclose certain telephone numbers where they are the general contact numbers for a business rather than an individual, and where the numbers are publicly available and where the name of the businesses have already been released in the document.
- 98. However, on balance of the factors set out above, I am satisfied that it would be unreasonable to release the remaining personal affairs information in the documents.

Section 25 – Deletion of exempt or irrelevant information

- 99. Section 25 requires an agency to grant access to an edited copy of a document where it is practicable to delete exempt or irrelevant information and the applicant agrees to receiving such a copy.
- 100. Determining what is 'practicable' requires consideration of the effort and editing involved in making the deletions 'from a resources point of view' and the effectiveness of the deletions. Where deletions would render a document meaningless, they are not 'practicable' and release of the document is not required under section 25.¹³

101. It is practicable to provide the Applicant with edited copies of the documents with exempt information deleted in accordance with section 25.

Conclusion

- 102. On the information before me, I am satisfied certain information in the documents is exempt from release under section 33(1). However, I have decided to release further information where I am not satisfied it is exempt from release.
- 103. It is practicable to edit the documents to delete exempt information in accordance with section 25. Accordingly, certain documents are to be released in part.

Timeframe to seek a review of my decision

- 104. If either party to this review is not satisfied with my decision, they are entitled to apply to VCAT for it to be reviewed.¹⁴
- 105. The Applicant may apply to VCAT for a review up to 60 days from the date they are given this Notice of Decision. 15
- 106. The Agency may apply to VCAT for a review up to 14 days from the date it is given this Notice of Decision. ¹⁶
- 107. Information about how to apply to VCAT is available online at www.vcat.vic.gov.au. Alternatively, VCAT may be contacted by email at admin@vcat.vic.gov.au or by telephone on 1300 018 228.
- 108. The Agency is required to notify the Information Commissioner in writing as soon as practicable if either party applies to VCAT for a review of my decision.¹⁷

Third party review rights

- 109. As I have determined to release certain information in the documents that the Agency identified as the personal affairs information of third parties and claimed exempt under section 33(1), if practicable, I am required to notify those third parties of their right to seek review by VCAT of my decision within 60 days from the date they are given notice.¹⁸
- 110. In this case, I am satisfied it is practicable to notify the relevant third parties of their review rights and confirm they will be notified of my decision as soon as practicable.

When this decision takes effect

111. My decision does not take effect until the third parties' 60 day review period expires. If a review application is made to VCAT, my decision will be subject to any VCAT determination.
